

**TERMS AND CONDITIONS APPLY TO AND GOVERN YOUR PARTICIPATION IN THE
« AFRIQUE 2017 » (“Promotion”)**

Article 1: Organization

The promoter of this Promotion is Western Union Financial Services Inc., 12500 E. Belford Ave, Englewood, Colorado 80112, USA (“Promoter”).

This Promotion commence on 14th January 2017 Saturday and ends on 14th January 2017 Tuesday (“Promotion Period”) and is subject to extension by the Promoter.

For the purposes of the present and the whole of the settlement, the dates and times will be based on Paris, France.

Article 2: Participation

Entry is open to Metropolitan France (Corsica included) residents aged 18 years or above who satisfy the entry requirements.

Employees (and their immediate families) of the Promoter, Western Union® Agents and Sub-agents, and service providers/marketing agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin who send at least 200€ to Maghreb or Sub-Saharan Africa country in all the agent locations offering the Western Union service in metropolitan France or on westernunion.com are ineligible to enter.

Entries received after 14th January 2017 Tuesday (or such later Promotion Period end date) will not be accepted and will be deemed invalid.

It is strictly forbidden, by any way, to edit or attempt to edit the games devices offered, to modify the results or to influence by automated or unfair means the validity of the draw or the designation of a winner.

Article 4: Prizes

Article 5: Conditions applicable to the award of the prizes.

Prizes may not be grounds for any dispute whatsoever or claim of any kind. Prizes must be accepted as awarded and may not be transferred, substituted, or redeemed for cash.

However, where force majeure, the Promoter reserves the right to replace the prizes offered with a replacement prize of equivalent nature and equal value if circumstances completely beyond their control compelled, without his liability being incurred as a result.

Each Participant shall authorize the Promoter to carry out all the necessary checks relating to the identity. All false revelations will result in the winner and all his or her entries being declared invalid.

Article 6: Rules

Postage costs at the current related to the rules and/or the amendment(s) will be reimbursed at the current low rate, on the request of the settlement. One reimbursement request only, for a single and unique participant.
All incomplete or incorrect request will not be considered.

Article 7: Litigation and Responsibilities

The liability of the Promoter shall not be engaged if, due to an event of force majeure or any event which is outside of its control, the Game should be modified, cut short or cancelled.

The Promoter reserves the right to extend the participation time limit and postponing any event announced or cancel the game.

The Promoter may modify or cancel all or part of the Game should it appear that fraud has been committed in any form whatsoever, and in particular via computer in the context of any participation in the Game.

The Promoter reserves the right in such an event not to award the prizes to parties who have committed a fraud and/or to bring proceedings before the competent courts against the parties to have committed such frauds.

No reply will be given to any request by telephone or in writing concerning the interpretation or application of the present rules, the mechanisms, or conditions of the Game, or concerning the list of winners.

The present Game and any dispute or any claim resulting therefrom or in connection therewith are governed by French law and shall be construed in accordance with French law.

Article 8: Evidence Convention

Except in the case of obvious errors, it is agreed that the information resulting from the Western Union gaming systems has probative force in any dispute.

Article 9: Protection of personal data

Under the law n°78-17 of 6 January 1978 on computers, files and liberties, it is specifying that personal data collected from participants within present Game are mandatory to validate the participation to this game, and will be treated by Western Union.
